Do you have a great idea for improving the care at your practice that involves the use of health IT? The Agency for Healthcare Research and Quality (AHRQ), through the Division of Health Information Technology (IT), is funding a variety of projects related to usability and safety for health IT systems, use of health IT for patient-reported outcomes, and scaling up and generating new clinical decision support tools related to patient-centered outcomes research.

AHRQ funding: \$1,987,438 over 4 years

AHRQ funding: \$1,184,548 over 4 years

Adoption of EHR systems at **3 nurse-managed health centers (NMHCs)** and **3 federally qualified health centers (FQHCs)** to support chronic disease management for **vulnerable populations**

3 Creating Online Newborn Intensive Care Unit (NICU) Networks to Educate, Consult & Team

AHRQ funding: \$1,499,995 over 4 years

Project CONNECT included **9 rural, federally qualified health centers (FQHCs)** that implemented an interoperable system and decision support tool to share electronic health information of **high-risk neonates being discharged** from the NICU to the community

Projects large and small are eligible for consideration. AHRQ reviews grant applications for funding three times a year; **deadlines and budget guidelines vary** for each mechanism and funding announcement.
